

Lake Poinsett Lake-Wide Cleanup

Beginning June 21

The Lake Poinsett Sanitary District is pleased to provide the Lake Poinsett lake-wide cleanup beginning June 21st.

All residential property owners that have garbage through the Lake Poinsett Sanitary District (LPSD) are welcome to participate. Items must be placed at the side of the road in front of your residence by 6 a.m. on June 21st. Please do not start placing items out for collection until the third week of June. The LPSD and Brookings Dumpster Service (BDS) reserve the right to decline picking up any piles that do not meet the conditions outlined in this flyer.

ALL ITEMS MUST BE SORTED AND SEPARATED. MIXED PILES WILL NOT BE PICKED UP.

Acceptable Items:

- WOOD: needs to be cut into manageable sizes of 4 feet in length, at maximum
- GLASS: all items containing glass must have it removed and placed in a separate container
- FURNITURE: do not allow these items to become saturated with water. Cover with a tarp if put out before the cleanup date

- CARPET: must be cut into manageable sizes
- APPLIANCES: stoves, microwaves, water heaters, etc. (exclude items containing Freon)
- IRON / SCRAP METAL: must be sorted and in manageable sizes
- EQUIPMENT: all fluids and liquids must be drained; oil, gasoline, etc.
- MISC. MATERIALS: no contaminants, paint cans cannot contain wet pain
- GENERAL WEIGHT RESTRICTION RULE: "If you can't lift it we can't either"

Unacceptable Items:

Yard waste, household refuse, hazardous waste, waste oil, liquid paint or chemicals, items containing Freon, batteries, branches, tires, concrete

Remodeling and construction materials are not allowed unless prior arrangements are made with Brookings Dumpster Service before the cleanup date. Extra fees apply.

LAKEWALK — West Lake Drive to Prairie Quay Drive. Park at Sorenson's Public Access



LPA to Begin Water Quality (WQ) Monitoring on Lake Poinsett

One of the goals of the Lake Poinsett Association (LPA) is to watch for unhealthy watershed issues and work with the homeowners, local business and local and state governments to protect our lakes. The LPA has an opportunity to carry out water quality sampling under the South Dakota Department of Agriculture & Natural Resources (DANR) Watershed Protection Program. Trained volunteers will collect water samples of Lake Poinsett throughout the summer. The data we collect will be utilized by the state and placed on their website.

Is there a cost to test water quality? Yes, fees are approximately \$1400. A portion of these costs are generously covered for two years by East Dakota Water Development District of Brookings and the South Dakota Discovery Center in Pierre. After two years the Lake Poinsett Association (LPA) is fully responsible for funding this program.

Are Lake Albert and Dry Lake analyzed for water quality? Dry Lake is not assessed currently. Lake Albert has a standard level of testing by the DANR, with gap years of no testing. We hope to sample these lakes when more funding is available.

How does data collection and testing help us?

Data provides a historical picture for future generations.

Should a pollution event occur, this information may be helpful to acquire additional funding for water quality improvements.

What happens if our data shows impaired water? If the lake is identified as being impaired, it is included on the state's list of impaired and threatened waters. A report must be written by the state with a plan to reduce the identified nutrient/pollutant.

"In time we will learn what water quality issues face Lake Poinsett and how common they are. Our data will help water quality managers identify if significant pollution sources are present on the lake."

What nutrient/pollutants do we collect? Volunteers take water samples looking for seven lake nutrient/ pollutants: Total Phosphorus, Total Kjeldahl Nitrogen, Nitrite/Nitrate, Chlorophyll-a, Ammonia, Algal Toxins, and E. coli. Some of these nutrients are natural occurring and beneficial nutrients needed for aquatic plants and animals to grow. However, even a small increase in these nutrients contributes to nuisance algae and plant growth.

What are the issues when phosphorus and soil erosion team up? Soil erosion is a major contributor of phosphorus overload in lakes. Phosphorus binds to soil and enters lakes as runoff. Home owners have replaced native plants and filtering wetlands with mowed lawns, riprap and retaining walls. Consequently, runoff carrying phosphorous has less chance of being filtered before reaching the water and adds to the phosphorus rich sediment buildup in the lake. Phosphorous feeds and grows algae.

How do these nutrients/pollutants impact the fishery? An overabundance of nutrients leads to excessive algae growth which becomes a blue-green algae bloom, which produces harmful toxins, foul odor and unappealing water. When the algae bloom dies and begins to decay, it depletes oxygen levels, causing a dead zone that negatively impacts fish and other aquatic life.

What are the primary sources of excessive nutrient/ pollutants in lakes? Polluting sources include runoff from snowmelt and rainfall that carries animal waste from feedlots and fields; fertilized lawns; failing septic systems; dumping waste directly into drains, ditches, or sloughs that flow into the lake; wildlife that uses the water as their natural habitat (goose, ducks, and cattle.)

Why is testing vital? Excessive nutrients create the conditions for a toxic blue-green algae bloom. It's not a true algae or bacteria but it produces a toxin making people and animals sick. Contact with affected water can cause skin irritation, mild respiratory effects, tingling in fingers and toes, numbness in the lips, and hay fever-like symptoms. Ingesting toxins can cause vomiting, diarrhea, fever and headaches. We cannot tell if blue-green algae is toxic just by looking at it. Testing a sample will confirm its toxicity. Protect yourself by avoiding water that is discolored, or where foam or scum is present.

What if my family or my pets get sick from bluegreen algae? Seek medical treatment immediately and notify your doctor/veterinarian about the exposure. Doctors may not be familiar with the human health symptoms. Tell them you have been swimming in a lake.

Am I safe from blue-green algae if I don't swim near it? Contact with water not visibly affected by bluegreen algae is not expected to cause health effects. Humans and pets should shower with clean water and soap after swimming in a lake.

What does E. coli testing reveal? Escherichia coli, commonly referred to as E. coli, is tested to determine whether a lake is suitable for swimming. E. coli is a bacteria that comes from human or animal waste. When E. coli exceeds the permissible level, it results in the closing of beaches for swimming and fishing.

Can fish be contaminated with E-coli? Because fish cold-blooded, E.coli is not found within their flesh. However, the water covering the fish could contain E.coli. Wash and cook fish thoroughly before eating and wash your hands after handling fish.

- Elevated levels of nitrate are common in groundwater in agricultural areas. Have your well tested once a year for bacteria, nitrates, and pH levels.
- In animals, toxin poisoning can cause weakness, staggering, difficulty in breathing, convulsions and death. If your pet walks through blue green algae on the shoreline, don't let it lick its paws; rinse your pet's feet as quickly as possible with clean water.
